Towards Precision Medicine Therapies and Biomarkers for Neurodegenerative Diseases

The mysteries of the brain with more than six million and the national effort from here in Florida to find the causes and cure for Alzheimer's disease are the focus of our April Club meeting. Dr. Nilüfer Ertekin-Taner from the Mayo Clinic in Jacksonville will share her insights as both a research scientist and practicing neurologist specializing in Alzheimer's care and behavioral neurology. She is a Professor and Research Chair o f Mayo's Department o f Neuroscience and was recently awarded a \$41 million grant from the National Institute on Aging to lead a national study on precision treatments in Alzheimer's.

She leads a lab team of 20 scientists in pursuit of identifying diagnostic biomarkers for Alzheimer's and cures. She also sees patients with dementia. "Alzheimer's is the most common cause of dementia and it has a specific fingerprint in the brain... specific changes in the brain, including accumulation of sticky proteins and other things that interfere with its normal function," she said. It's a very common disease,

people in the U.S. and 50 million across the world who live with the oftendebilitating condition. she added.

She'll discuss the very latest research efforts and the progress being made in earlier diagnosis and treatment toward ultimately finding a cure, as well as her insights on the caregiver family experience. Plus, as always, questions from our Club members.

Dr. Ertekin-Taner been continually funded by the National Institutes o f Health foundations, serving as a Principal Investigator on 37 grants totaling about \$80 million since 2008. With 21% of its 22.5 million residents age 65plus, Florida has a lot to gain personally and economically from Alzheimer's research. It is one of the few states that directly supports such research.

A native of Turkey and the daughter of two neurologists, Dr. Ertekin-Taner received

The Radical Consequences of a Digital Economy

The March Club meeting featured Bob Rice. Managing Partner of New Jerseybased Tangent Capital broker-Partners, а dealer specializing in private investments. He presented an eveopening look at how the inventions of the digital camera, personal computer, and the Internet have resulted in today's digital economy that will now change our lives

beyond anything else in our lifetime.

"The latest iteration is Artificial Intelligence or AI, created by machine, and it's just getting started. The advances and the consequences are mind-blowing and we have to be ready," Mr. Rice said.

He showed Club members short videos of common real-life situations and fictional artistic representations involving people and animals, created from scratch by AI from a simple spoken human command to a computer. Such AI-created videos have prompted one Hollywood producer to put on-hold a planned \$800 million studio expansion and predict future job losses in the field.

"It's a revolutionary revolution and the reason is because it's not happening in one domain of human existence or knowledge...it applies to absolutely everything. There is no kind of human endeavor to which this doesn't apply," said Rice, author of three books on private investment and an adjunct Professor of Law at Florida State University, teaching how the law impacts the business of investment management.

While "no one really knows what this all means and where it will lead," Mr. Rice referenced a McKinsey & Company study, which projects that by 2030 Generative Al will double the growth of productivity and increase the world's annual Gross Domestic Product (GDP) by \$4 trillion, an amount equal to the GDP of Germany or Japan. Total Al will increase GDP by \$17 trillion, equal to China's annual GDP, with impacts on business competition and investment, Mr. Rice explained.
