
The Challenges of Leadership in Our Times

Former CIA Director and Defense Secretary Leon Panetta joins us this month to discuss the growing challenges and turmoil facing the United States from forces within and outside the federal government in what he describes as a "crisis of leadership." His address to the Club is fresh off his January 30 testimony before the U.S. House of Representative's Select Committee on China. The hearing focused on China's support for U.S. adversaries.

"In a democracy, we govern either by leadership or by crisis." Mr. Panetta told Club Officers in a recent conference call. "Unless you're willing to take the risks associated with leadership, including offending your own base, you're not going to provide leadership. If you don't, then we're governed by crisis. Rather than fixing the crisis, they just kick the can down the road. And so, our system is not just broken on the budget, I think our democracy is broken in terms of our ability to govern," which he said is sending a message to allies and adversaries "that the U.S. is weak." His livestreamed appearance before the Club will be through a live question and answer conversation with Club Board member Ash Williams, of J.P. Morgan Asset Management.

Mr. Panetta is Chairman of The Panetta Institute for Public Policy at California State University, Monterey Bay. As a former director of the federal Office of Management and Budget (OMB), his goals include building a structure for an effective, responsible federal budget and getting Congress to adopt a commission on the larger debt issue.

A Monterey native and Santa Clara University School of Law graduate, Mr. Panetta began his long and distinguished public service career in 1964 as a U.S. Army intelligence officer and afterward went into federal government service. He has served as Director of the U.S. Office for Civil Rights and as a member of Congress for 16 years, including Chair of the House Budget Committee. In 1993, he left Congress to serve President Clinton as

OMB director and later chief of staff. In 2008, he left the Panetta Institute to serve as President Obama's Director of the Central Intelligence Agency and later as Secretary of Defense.

Mr. Panetta will be introduced by Club Board member Raymond Bye, an independent government relations consultant.

2024 Economic Outlook

The January Club meeting featured financial analyst Henry McVey, a partner and head of the Global Macro, Balance Sheet and Risk team at New York investment firm KKR. He discussed his views on the current global situation, including **US** monetary policy, the economy in China, and the effects of

the Russia-Ukraine war. He said that the top 100-countries are looking for security in energy after Russia/Ukraine, and security in water, food, and transportation.

Mr. McVey told Club members that for the past ten to twenty years, the world has seen a low-inflation, low-growth environment where central banks experimented in monetary policy with little risk. Now things are more flexible with unsettled supply chains, messy energy transformation, and future shortages of labor and housing. The banks have also imposed a tight money environment.

In a reversal of the way markets have acted in recent years, now stocks and bonds mirror each other, and portfolios are not acting the way they did in the past. He said 2024 is a very different investment environment and that it will take a while for monetary policy to play out. Countries that were at the back of the pack in the last financial crisis are outpacing the core now.

Mr. McVey said the US decision to not join the Trans-Pacific Partnership forced the Asian countries to form an Asian circle. As for China, he says it formerly had a 10-12% growth rate – now it's down to 5%.

"China is trying to create a powerhouse of industrial automation by upgrading technology and manufacturing. They are concentrating on batteries and cars. What's not driving growth is housing. They have between five and 50-million excess houses," McVey said. He also pointed out that their zero COVID policies are weighing on consumers. He minimized the possibility that China would militarily invade Taiwan.

For our individual portfolios, Mr. McVey recommended:

- Have a long-term plan
- Have the courage to stick with the plan
- Diversify with investments in real estate, passive infrastructure, and stocks and bonds.
