## The U.S. Navy's Economic and Strategic Impact from Florida around the Globe

We're honored to have with us this month **Meredith Berger**, Assistant
Secretary of the Navy for Energy, Installations, and Environment, who also serves as the Navy's Chief Sustainability Officer. Her responsibility for oversight and policy covers six major areas:

- Navy and Marine Corps energy and climate resilience
- Infrastructure sustainment, restoration and modernization
- Military construction
- Acquisition, utilization and disposal of real property and facilities
- Environmental protection, planning, restoration and natural resources conservation
- Safety and occupational health

Assistant Secretary Berger will share the significant presence the military has in Florida and the key roles it plays in naval operations around the world. Its Navy facilities include one Naval Station, four Naval Air Stations, and two Naval Support Activity facilities. Florida is also home to the U.S. Southern Command in Doral and the U.S. Central Command in Tampa. Plus, as always, she'll take Club members' questions.

Ms. Berger has served in a variety of policy and senior leadership positions in both

federal and state government and the private sector. Prior to her current assignment in 2021, she was a senior manager for the **Defending Democracy** Project at Microsoft Corporation. She was also a Fellow with the Harvard Kennedy School's Belfer Center for Science and International Affairs. She began her public service career in Florida, with the state Chief Financial Officer's office, where she developed and executed state policies on climate, insurance, risk, energy, public finance, and housing.

Ms. Berger joined the Obama Administration in 2011 as a policy advisor at the Environmental Protection Agency where she worked on the Presidential Task Force focused on the long-term recovery of the Gulf of Mexico following the Deepwater Horizon oil spill. She then served as Deputy Chief of Staff to Secretary of the Navy Ray Mabus. She was also a Department of Defense Fellow.

Ms. Berger holds a Bachelor of Arts in American Studies and Spanish from Vanderbilt University, a Juris Doctor from Nova Southeastern University, and a Master



of Public Administration from the Harvard Kennedy School. She was awarded the Secretary of the Navy Distinguished Civilian Service Medal, Secretary of Defense Medal for Exceptional Public Service, and the EPA Gold Medal for Exceptional Service. Ms. Berger will be introduced by Club Board member Raymond Bye, former Vice President of Research at Florida State University.

### **Conservation is Good for Business**

The September Club meeting featured Jessica Harvey, daughter of wildlife artist and conservationist Guy Harvey, and the CEO of the Guy Harvey Foundation. The Fort Lauderdale-based foundation funds ocean raises for education. research. and conservation. She shared what life was like growing up with her father, their shared love of fishing, and how "art and

science always went hand in hand for us."

Guy Harvey's paintings of natural scenes now grace everything from museum walls to coffee cups, and part of the money made goes to fund the foundation. "It's very hopeful and uplifting, and because of that, more people want to be associated with the brand," Ms. Harvey told Club members. "It's branched out into people wanting Guy Harvey F-150s, so we had a licensing agreement with Ford. Norwegian Cruise Lines wanting to feature dad as the hull art, which they do on all of their ships. It's not only become a feature of the art, but a billboard for conservation and support," she said.

Mr. Harvey pointed out the importance of water to Florida's economy. Nearly 52 million recreational anglers in Florida provide an economic impact of \$140-billion, with boating and fishing employing thousands of Floridians. Across the U.S., 100 million Americans boat annually, with a \$230 billion economic impact. "There is a way we can coexist with wildlife that is helping support their conservation, as well as supporting the economy that we all benefit from," she said.

The foundation began a relationship with Nova Southeastern University in 1999 to do research on pelagic fish – those that live in open waters – including sharks and billfish. It also hosts educational programs in three states and 20 Florida counties, providing grants for teacher training and field trips. It also works directly with businesses.

"We're working with Intradeco (a Miami-based apparel company) who have prioritized working with everything from sustainable sources of materials to recycling the water used in the dyeing process of the fabrics, so that it's not taking any added water from the community."
